

Anti-Bribery and Corruption Policy

V4.5 032026

1. Introduction

- 1.1 It is our policy to conduct all of our business in an honest and ethical manner. We take a zero-tolerance approach to bribery and corruption and are committed to acting professionally, fairly and with integrity in all our business dealings and relationships wherever we operate and implementing and enforcing effective systems to counter bribery and corruption.
- 1.2 We will uphold all laws relevant to countering bribery and corruption in all the jurisdictions in which we operate. However, we remain bound by UK laws, including the Bribery Act 2010, in respect of our conduct both at home and abroad.

2. Purpose of the policy

- 2.1 The purpose of this policy is to:
 - 2.1.1 set out our responsibilities, and of those working for us, in observing and upholding our position on bribery and corruption; and
 - 2.1.2 provide information and guidance to those working for us on how to recognise and deal with bribery and corruption issues.
- 2.2 It is a criminal offence to offer, promise, give, request, or accept a bribe. Individuals found guilty can be punished by up to ten years' imprisonment and/or a fine. As an employer if we fail to prevent bribery, we can face an unlimited fine, exclusion from tendering for public contracts, and damage to our reputation. We therefore take our legal responsibilities very seriously.
- 2.3 In this policy, **third party** means any individual or organisation you encounter during the course of your work for us, and includes actual and potential clients, customers, suppliers, distributors, business contacts, agents, advisers, and government and public bodies, including their advisors, representatives and officials, politicians and political parties.
- 2.4 This policy does not form part of any employee's contract of employment, and we may amend it at any time.

3. Who must comply with this policy?

This policy applies to all persons working for us or on our behalf in any capacity, including employees at all levels, directors, officers, sub-contractors, suppliers, contractors, external consultants, seconded workers, volunteers, interns, third-party representatives and business partners, sponsors, or any other person associated with us, wherever located.

4. Who is responsible for the policy?

- 4.1 The board of directors has overall responsibility for ensuring this policy complies with our legal and ethical obligations, and that all those under our control comply with it.
- 4.2 The Chief Legal and Operating Officer has primary and day-to-day responsibility for implementing this policy, monitoring its use and effectiveness, dealing with any queries about it, and auditing internal control systems and procedures to ensure they are effective in countering bribery and corruption.
- 4.3 Management at all levels are responsible for ensuring those reporting to them understand and comply with this policy and are given adequate and regular training on it.
- 4.4 You are invited to comment on this policy and suggest ways in which it might be improved. Comments, suggestions and queries should be addressed to the People Business Partner.

5. Summary of bribery and corruption

- 5.1 **Bribery** is offering, promising, giving or accepting any financial or other advantage, to induce the recipient or any other person to act improperly in the performance of their functions, or to reward them for acting improperly, or where the recipient would act improperly by accepting the advantage.
- 5.2 An **advantage** includes money, gifts, loans, fees, hospitality, services, discounts, the award of a contract or anything else of value.
- 5.3 A person acts **improperly** where they act illegally, unethically, or contrary to an expectation of good faith or impartiality, or where they abuse a position of trust. The improper acts may be in relation to any business or professional activities, public functions, acts in the course of employment, or other activities by or on behalf of any organisation of any kind.
- 5.4 **Corruption** is the abuse of entrusted power or position for private gain.

Examples:

Offering a bribe: You offer a potential client tickets to a major sporting event, but only if they agree to do business with us.

This would be an offence as you are making the offer to gain a commercial and contractual advantage. We may also be found to have committed an offence because the offer has been made to obtain business for us. It may also be an offence for the potential client to accept your offer.

Receiving a bribe: A supplier gives your nephew a job but makes it clear that in return they expect you to use your influence in our organisation to ensure we continue to do business with them.

It is an offence for a supplier to make such an offer. It would be an offence for you to accept the offer as you would be doing so to gain a personal advantage.

Bribing a foreign official: You arrange for the business to pay an additional "facilitation" payment to a foreign official to speed up an administrative process.

The offence of bribing a foreign public official is committed as soon as the offer is made. This is because it is made to gain a business advantage for us. We may also be found to have committed an offence.

6. What you must not do

6.1 It is not acceptable for you (or someone on your behalf) to:

- 6.1.1 give, promise to give, or offer, a payment, gift or hospitality with the expectation or hope that a business advantage will be received, or to reward a business advantage already given.
- 6.1.2 give or accept a gift or hospitality during any commercial negotiations or tender process, if this could be perceived as intended or likely to influence the outcome.
- 6.1.3 accept a payment, gift or hospitality from a third party that you know, or suspect is offered with the expectation that it we will provide a business advantage for them or anyone else in return.
- 6.1.4 accept hospitality from a third party that is unduly lavish or extravagant under the circumstances.
- 6.1.5 offer or accept a gift to or from government officials or representatives, or politicians or political parties without the prior approval of the Directors;
- 6.1.6 disclose any Company confidential, proprietary information or intellectual property to any unauthorised parties.
- 6.1.7 threaten or retaliate against another individual who has refused to commit a bribery offence or who has raised concerns under this policy.
- 6.1.8 engage in any other activity that might lead to a breach of this policy.

7. Remuneration

Our organisation is committed to ensuring that all forms of remuneration are fair, transparent, and do not create incentives for unethical behaviour. We will not tolerate any attempt to offer or receive inappropriate or undue compensation, including salaries, bonuses, commissions, profit share, or other benefits, to influence any business decision or action. Our Company will regularly review its remuneration practices to ensure that they comply with applicable laws and regulations and align with industry standards. Any employee who engages in or facilitates inappropriate or undue compensation or benefits will be subject to disciplinary action, up to and including termination of employment.

8. Facilitation payments and kickbacks

8.1 We do not make, and will not accept, facilitation payments or "kickbacks" of any kind.

8.2 Facilitation payments, also known as "back-handers" or "grease payments", are typically small, unofficial payments made to secure or expedite a routine or necessary action (for example by a government official). They are not common in the UK but are common in some other jurisdictions.

8.3 Kickbacks are typically payments made in return for a business favour or advantage.

8.4 You must avoid any activity that might lead to a facilitation payment or kickback being made or accepted by us or on our behalf, or that might suggest that such a payment will be made or accepted. If you are asked to make a payment on our behalf, you should always be mindful of what the payment is for and whether the amount requested is proportionate to the goods or services provided. You should always ask for a receipt which details the reason for the payment. If you have any suspicions, concerns or queries regarding a payment, you should raise these with a Director.

9. Gifts, hospitality and expenses

9.1 This policy allows reasonable and appropriate hospitality or entertainment given to or received from third parties, for the purposes of:

- 9.1.1 establishing or maintaining good business relationships;
- 9.1.2 improving or maintaining our image or reputation; or
- 9.1.3 marketing or presenting our products and/or services effectively.

9.2 You are prohibited from accepting a gift from or giving a gift to a third party.

9.3 Promotional gifts of low value such as branded stationery to or from existing customers, suppliers and business partners will usually be acceptable, but must be approved by a Director.

9.4 Reimbursing a third party's expenses or accepting an offer to reimburse our expenses (for example, the costs of attending a business meeting) would not usually amount to bribery. However, a payment in excess of genuine and reasonable business expenses (such as the cost of an extended hotel stay) is not acceptable.

9.5 We appreciate that practice varies between countries and regions and what may be normal and acceptable in one region may not be in another. The test to be applied is whether in all the circumstances the gift, hospitality or payment is reasonable and justifiable. The intention behind it should always be considered.

10. Extortion

Extortion is strictly prohibited within our Company, and we will not tolerate any form of intimidation, coercion, or threats in the course of business. Any employee who engages in extortion or attempts to use their position to improperly influence or obtain anything of value from another person or entity will be subject to disciplinary action, up to and including termination of employment. Additionally, any other non-employee or third party who engages in extortion related to our business will be immediately reported to the appropriate authorities.

11. Theft

Our Company prohibits all forms of theft, including the theft of physical assets, intellectual property, and confidential information. Any employee who engages in theft, whether it is from the organization, other employees, or third parties, will be subject to disciplinary action, up to and including termination of employment.

Additionally, any third party who engages in theft related to our business will be immediately reported to the appropriate authorities.

12. Tax evasion

Our organization is committed to complying with all applicable tax laws and regulations. Tax evasion is strictly prohibited, and we will not tolerate any attempts to evade or fraudulently minimise our tax obligations. Any employee who knowingly participates in or assists in tax evasion, including failing to report or underreporting income, will be subject to disciplinary action, up to and including termination of employment. Additionally, any third party who engages in tax evasion related to our business will be immediately reported to the appropriate authorities. We encourage all employees to report any suspected incidents of tax evasion, and we will investigate all reports thoroughly and take appropriate action in response.

13. Donations, Contributions, Sponsorships and Community Investment

13.1 We do not make contributions to political parties (whether direct or indirect).

13.2 We only make charitable donations, sponsorships, and/or community investments that are legal and ethical under local laws and practices and undertaken in accordance with our CCSP policy. Any breach of the CCSP policy will be treated as a breach of this policy.

14. Nepotism and cronyism

Our organization is committed to ensuring a fair and unbiased approach to employment, promotion, and other business opportunities. Nepotism and cronyism are strictly prohibited and will not be tolerated. All employees will be selected, promoted, and given business opportunities based on merit, qualifications, and performance criteria. Any employee who engages in nepotism or cronyism or attempts to use their position to improperly influence or obtain opportunities for themselves or their associates will be subject to disciplinary action, up to and including termination of employment. Additionally, any third party who engages in nepotism or cronyism related to our business will be immediately reported to the appropriate authorities.

15. Record-keeping

15.1 We must keep financial records and have appropriate internal controls in place which will evidence the business reason for making payments to third parties.

15.2 You must declare and keep a written record of all hospitality or gifts given or received, which will be subject to managerial review.

15.3 You must submit all expenses claims relating to hospitality, gifts or payments to third parties in accordance with our expenses policy and record the reason for expenditure.

15.4 All accounts, invoices, and other records relating to dealings with third parties including suppliers and customers should be prepared with strict accuracy and completeness. Accounts must not be kept "off-book" to facilitate or conceal improper payments.

16. Your responsibilities

16.1 You must ensure that you read, understand and comply with this policy.

16.2 The prevention, detection and reporting of bribery and other forms of corruption are the responsibility of all those working for us or under our control. You are required to avoid any activity that might lead to, or suggest, a breach of this policy.

16.3 We encourage all employees to report any suspected incidents of theft, and we will investigate all reports thoroughly and take appropriate action in response.

16.4 You must notify your manager, Chief Legal and Operating Officer, or the confidential helpline (where available) as soon as possible if you believe or suspect that a conflict with this policy has occurred or may occur in the future. For example, if a client or potential client offers you something to gain a business advantage with us or indicates to you that a gift or payment is required to secure their business. Further "red flags" that may indicate bribery or corruption are set out in clause 20.

17. How to raise a concern

17.1 You are encouraged to raise concerns about any issue or suspicion of bribery or corruption at the earliest possible stage.

17.2 If you are offered a bribe, or are asked to make one, or if you believe or suspect that any bribery, corruption or other breach of this policy has occurred or may occur, you must notify your manager or the Chief Legal and Operating Officer or report it in accordance with our Whistleblowing Policy as soon as possible.

17.3 If you are unsure about whether a particular act constitutes bribery or corruption, raise it with your manager or the Chief Legal and Operating Officer.

18. Protection

18.1 Individuals who refuse to accept or offer a bribe, or who raise concerns or report another's wrongdoing, are sometimes worried about possible repercussions. We aim to encourage openness and will support anyone who raises genuine concerns in good faith under this policy, even if they turn out to be mistaken.

18.2 We are committed to ensuring no one suffers any detrimental treatment as a result of refusing to take part in bribery or corruption, or because of reporting in good faith their suspicion that an actual or potential bribery or other corruption offence has taken place or may take place in the future. Detrimental treatment includes dismissal, disciplinary action, threats or other unfavourable treatment connected with raising a concern. If you believe that you have suffered any such treatment, you should inform the compliance manager immediately. If the matter is not remedied, and you are an employee, you should raise it formally using our Grievance Procedure set out in our Team Handbook.

19. Training and communication

19.1 Training on this policy forms part of the induction process for all individuals who work for us, and regular training will be provided as necessary.

19.2 Our zero-tolerance approach to bribery and corruption must be communicated to all suppliers, contractors and business partners at the outset of our business relationship with them and as appropriate thereafter.

20. Breaches of this policy

20.1 Any employee who breaches this policy will face disciplinary action, which could result in dismissal for misconduct or gross misconduct.

20.2 We may terminate our relationship with other individuals and organisations working on our behalf if they breach this policy.

20.3 We may refer any incident to the police for investigation.

21. Potential risk scenarios: "red flags"

21.1 The following is a list of possible red flags that may arise during the course of you working for us and which may raise concerns under various anti-bribery and anti-corruption laws. The list is not intended to be exhaustive and is for illustrative purposes only.

16.2. If you encounter any of these red flags while working for us, you must report them promptly to your manager **or** to the compliance manager **or** using the procedure set out in the whistleblowing policy:

21.1.1 you become aware that a third party engages in, or has been accused of engaging in, improper business practices;

21.1.2 you learn that a third party has a reputation for paying bribes, or requiring that bribes are paid to them, or has a reputation for having a "special relationship" with foreign government officials;

21.1.3 a third party insists on receiving a commission or fee payment before committing to sign up to a contract with us, or carrying out a government function or process for us;

21.1.4 a third-party requests payment in cash and/or refuses to sign a formal commission or fee agreement, or to provide an invoice or receipt for a payment made;

21.1.5 a third-party request that payment is made to a country or geographic location different from where the third party resides or conducts business;

21.1.6 a third party requests an unexpected additional fee or commission to "facilitate" a service;

21.1.7 a third party demands lavish entertainment or gifts before commencing or continuing contractual negotiations or provision of services;

- 21.1.8 a third-party request that a payment is made to "overlook" potential legal violations;
- 21.1.9 a third-party request that you provide employment or some other advantage to a friend or relative;
- 21.1.10 you receive an invoice from a third party that appears to be non-standard or customised;
- 21.1.11 a third party insists on the use of side letters or refuses to put terms agreed in writing;
- 21.1.12 you notice that we have been invoiced for a commission or fee payment that appears large given the service stated to have been provided;
- 21.1.13 a third party requests or requires the use of an agent, intermediary, consultant, or supplier (e.g. an umbrella company) that is not typically used by or known to us and or you are offered incentives to allow that third party to use such agent, intermediary, consultant, or supplier;
- 21.1.14 you are offered an unusually generous gift or offered lavish hospitality by a third party;

22. Monitoring

Training on anti-bribery and corruption is mandatory and will be formally included in the induction and repeated on an annual basis as part of the risk management process to monitor and mitigate corruption and bribery in the workplace. This policy will be reviewed annually by the Chief Legal and Operating Officer and any updates reported to senior management.
